United Group, Inc's warranty extends only to the original purchaser acquiring new products directly from United Group, Inc, its authorized dealers and distributors, or others specifically authorized by United Group, Inc. to act as resellers of its products. United Group, Inc. provides parts under warranty **only**.

Proof of purchase is **required** (serial #, photos of chair and failure, failure details, contact information).

This warranty is **void** if the product is modified or attachments are made to the product. Determination to replace product (applies to parts only) shall be made by United Group, Inc.

Warranty applies to IRON HORSE Seating products manufactured after September 1, 2005.

### **HEAVY DUTY FRAME WARRANTY**

10 Years from Date of Sale on 2000 Series, 3000 Series, 4000 Series, and Big & Tall. 5 Years from Date of Sale on 5000 Series.

### **STRUCTURAL COMPONENTS**

5 Years from Date of Sale; excluding product abuse, misuse, and normal wear and tear.

**CUSHIONS, TRIM, CASTERS & ARMRESTS** 

3 Years from Date of Sale; excluding product abuse, misuse, and normal wear and tear.

## 4D Armrests are NOT covered under Warranty if used in 24/7 environments.

### HD Tilt-Up & 3D Armrests ARE covered under Warranty if used in 24/7 environments.

# **IRON HORSE SEATING OFFICE CHAIR WARRANTY**

#### LIMITED WARRANTY PAGE 1/2

Warranty. Subject to the conditions and limitations set forth below. United Group, Inc. warrants Iron Horse office chair products are manufactured and delivered free from substantial defects in material and workmanship and will remain in such condition for the term described below. This warranty extends only to the original customer and is non transferable.

#### THIS WARRANTY DOES NOT APPLY, OR INCLUDE COVERAGE FOR, DEFECTS ATTRIBUTABLE TO:

A) NEGLIGENCE OR MISUSE.

B) FAILURE TO COMPLY WITH INSTRUCTIONS FOR SERVICE OR MAINTENANCE.

C) ACCIDENT, UNAUTHORIZED REPAIRS OR MODIFICATIONS OR UNAUTHORIZED USE.

D) DAMAGE OR PRODUCT FAILURE CAUSED BY FREEZING, FLOODING, FIRE OR ANY OCCURRENCE THAT MIGHT BE TERMED AN ACT OF GOD.

E) ITEMS ORDINARILY DEPRECIATED BY USE, IE; WEAR AND TEAR.

F) NORMAL MAINTENANCE ITEMS.

G) EXPOSURE TO THE ELEMENTS, EXCESSIVE HUMIDITY, FADING OR DISCOLORATION OVER TIME, FAILURE TO FOLLOW INSTRUCTIONS FOR SAID CLEANING, MAINTENANCE, CORROSIVE MATERIALS, IMPROPER LOADS, EXCESSIVE HEAT OR BURNS, AND NON UNITED GROUP, INC. SUPPLIED PARTS OR BRACKETS. H) ANY CONDITION OR DAMAGE FROM REMOVAL OR REINSTALLATION OF PRODUCT IN THE SAME OR OTHER APPLICATION UNLESS DIRECTED TO BY UNITED GROUP, INC.

Term. The provisions of this Warranty commence from the day the product is delivered to the end user defined by the invoice date included with the original shipment -

A) Ten (10) years from the date as defined above on the seat frame of the 2000 Series, 3000 Series, 4000 Series and Big & Tall.

B) Five (5) years from the date as defined above on the following components - 5000 Series seat frame, air lumbar, backrest recline mechanism, tilt mechanism, mounting plate, gas lift, star base, glides, base cushion slide mechanism, fasteners, bezels and any other internal mechanisms contained within the IRON HORSE office chair.

C) Three (3) years from the date as defined above on armrests, casters, seat backrest foam, seat base foam, seat covering material, headrest covering and foam.

#### \*4D Armrests are NOT covered under Warranty if used in 24/7 environments. \*HD Tilt-Up Armrests & 3D Armrests ARE covered under Warranty if used in 24/7 environments.

Exclusive Remedy. During the Warranty Period, United Group, Inc. will replace or provide replacement parts of the Iron Horse office chair product which conforms to the above Warranty, PROVIDED THAT THE FOLLOWING STEPS ARE TAKEN:

1) Contact United Group to report / start a Warranty claim. Phone 1 (847) 816 7100.

2) All parts used in conjunction with a Warranty repair are retained and may be asked to be returned to United Group, Inc. in a properly labeled package that will identify them as Warranty return part(s).
